According to current regulations<sup>1</sup> the European Commission assigns an identification number for each notified body. A notified body is assigned only one identification number even when it is notified under several EU laws. A list of notified bodies, together with the identification numbers and scopes of notified activities is published by the European Commission on the following website: www.ec.europa.eu/enterprise/newapproach/nando.

This document sets out rules for using the number 1438 which is the identification number of the notified body CNBOP-PIB.

- 1. Authorisation to use the identification number 1438 with CE marking is granted exclusively to the Manufacturer<sup>2</sup> or his authorized representative3, hereinafter referred to as the Holder, who CNBOP-PIB has granted European certification (EC certificate of conformity, EC-Type Examination) for a particular product.
- 2. The identification number 1438 should be used only with CE marking. The Holder must comply with the general rules governing the form, placement and use of CE marking contained in the Regulation No 765/2008 of the European Parliament and of the Council of 9 July 2008 setting out the requirements for accreditation and market surveillance relating to the marketing of products and repealing Regulation No 339/93 (O. J. EU L 218/30 of 13.08.2008).
- 3. The Holder for whom CNBOP-PIB suspended or withdrew European certification for a specific product, cannot use CNBOP-PIB identification number during the period of suspension or withdrawal of certification.
- 4. If, for any reason, European certification of a product has expired, the Holder is obliged to immediately cease using CNBOP-PIB identification number.
- 5. The Holder shall be obliged to cease using the number 1438 with CE marking in a way that CNBOP-PIB deems inadmissible.
- The Holder cannot assign its right to use CNBOP-PIB identification number on any entities (e.g. subcontractors). 6.
- 7. The number 1438 with CE marking cannot be used on business cards and/or stamps of the Holder of the Holder's personnel.
- 8. In the event of abuse of using CNBOP-PIB identification number, forgery or misleading reference to the granted European certification, CNBOP-PIB shall suspend or withdraw the granted certification.
- 9. In the event of abuse, forgery or misleading reference to the number 1438, the Institute reserves the right to undertake relevant actions, i.e.:
  - demand performance of relevant corrective actions,
  - suspension or withdrawal of the certificate,
  - publish information concerning illegal or false reference to the identification number of CNBOP-PIB notification,
  - resolve the matter in court.
